Fee Schedule Based on Type of Use

1. **Class I** – Shall mean Related Student Groups with students that primarily attend the district that are devoted to community interest and child welfare.
2. **Class II** – Central City organizations devoted to community interest and not operating for profit. Admission may be charged or donations may be solicited.
3. **Class III** – Merrick County Groups operating for profit or ^Merrick County organizations devoted to community interest and not operating for profit. Must prove student, school, or community benefit. The superintendent is authorized to make a decision on the merits of the application or refer the request to the Board of Education.
4. **Class IV** – Groups outside of Merrick County operating for profit. Must prove student, school, or community benefit. The superintendent is authorized to make a decision on the merits of the application or refer the request to the Board of Education.
