

MINUTES OF THE
CENTRAL CITY BOARD OF EDUCATION
DECEMBER 20, 2021

The Central City Board of Education met at 8:00 p.m., on Monday, December 20, 2021 in the Central City High School Conference Room at 1510 28th Street in Central City, NE 68826.

Pledge of Allegiance

Roll call showed the following members present: Brian Buhlke, Brent Kennedy, Lisa Wagner, and Brett Zikmund. Also present: Jeff Jensen, Superintendent; Absent: Homolka, Heins excused.

It was moved by Kennedy, seconded by Buhlke, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The cafeteria account disclosed a balance of \$58,552.96.
