April 18, 2022

The Central City Board of Education met at 8:00 p.m., on Monday, April 18, 2022 in the Central City High School Conference Room at 1510 28th Street in Central City, NE 68826.

Pledge of Allegiance

Roll call showed the following members present: Brian Buhlke, Chuck Homolka, Brent Kennedy and Lisa Wagner. Also present: Jeff Jensen, Superintendent; Absent: Aaron Heins and Brett Zikmund.

It was moved by Buhlke, seconded by Kennedy, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The high school activities fund account disclosed a balance on March 31, 2022 of \$190,264.08, middle school activity fund disclosed a balance of \$20,967.81, and the elementary activity fund disclosed a balance of \$7,994.31. The cafeteria account disclosed a balance of \$50,214.93.
