The school district treasurer's financial report disclosed a reconciled unencumbered balance of \$3,146,875.06 as of August 31, 2022.

The high school activities fund account disclosed a balance on August 31, 2022 of \$298,571.92, middle school activity fund disclosed a balance of \$18,853.84, and the elementary activity fund disclosed a balance of \$7,597.19. The cafeteria account disclosed a balance of \$40,780.81.

The Board Reviewed policies 3024, 3025, 3026, 3027, and 3028 with no Changes.

It was moved by Kennedy, seconded by Homolka, to approve the 2022-2023 Fiscal Year Budget. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.

It was moved by Heins, seconded by Homolka, to approve the 2022-2023 School Year Tax Request Resolution for Central City Public Schools. NOW BE IT THEREFORE RESOLVED that (1) the Tax Request for the General Fund should be, and hereby is at \$9,303,030.00 (2) the Tax Request for the Bond Fund should be, and hereby is set at \$353,535.00 (3) the Tax Request for the Special Building Fund should be, and hereby is set at \$530,303.00 and the Tax Request for the Qualified Capital Purpose Undertaking Fund should be, and hereby is set at \$186,869.00. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Kennedy, and Zikmund. Nays: None. Absent: Wagner.
