It was moved by Buhlke, seconded by Homolka, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The school district treasurer's financial report disclosed a reconciled unencumbered balance of \$3,927,415.67 as of October 31, 2023.

The high school activities fund account disclosed a balance on October 31, 2023 of \$191,719.45, middle school activity fund disclosed a balance of \$17,072.84, and the elementary activity fund disclosed a balance of \$14,757.72. The cafeteria account disclosed a balance of \$-5,087.64.

It was moved by Buhlke, seconded by Heins, to approve the agenda of the meeting. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

It was moved by Heins, seconded by Holmolka, to approve the consent agenda action items, which include minutes from October 16, 2023, financial review of funds, and November claims. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

The Board Reviewed policies 4053, 4056, 4057, 4058, and 4059 with no Changes.

It was moved by Heins, seconded by Zikmund, to approve the 2024-2025 Certified Staff Master Agreement with a 4.1% total package increase and \$950 on the Base. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

It was moved by Heins, seconded by Zikmund, to approve classified wages for 2024-2025 at a 3.5% increase for a total package of 4.2-4.5% increase. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

It was moved by Buhlke, seconded by Zikmund, to approve the 2022-2023 Fiscal Year Audit.

It was moved by Homolka, seconded by Buhlke, to approve the dissolution of the 2023-2024 Baseball Cooperative between Central City, Fullerton, and Centura. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

It was moved by Buhlke, seconded by Heins, to approve entering into a Baseball Cooperative with Centura for the 2023-2024 and 2024-2025 school years with such action to automatically renew such agreement for future NSAA renewal years. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

The board discussed, but took no action, on Administrative Wages and preliminary 2024-2025 Master Calendar.
