It was moved by Buhlke, seconded by Heins, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The school district treasurer's financial report disclosed a reconciled unencumbered balance of \$7,456,316.04 as of June 30, 2025.

The high school activities fund account disclosed a balance on June 30, 2025 of \$316,236.16, middle school activity fund disclosed a balance of \$19,784.89, and the elementary activity fund disclosed a balance of \$17,196.20. The cafeteria account disclosed a balance of \$-58,100.25.

It was moved by Buhlke, seconded by Heins, to increase Elementary Lunch 15 cents, Middle School Lunch 20 cents, High School Lunch 25 cents, Adult Lunch 35 cents, Breakfast 15 cents, and Milk 5 cents. It was moved by Heins, seconded by Zikmund, to approve the Superintendent as the District Representative for Local, State, and Federal Documents. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

It was moved by Holmolka, seconded by Zikmund, to declare items as surplus goods, as necessary, for the 2025-2026 school year. Motion carried 5-0. Ayes: Buhlke, Heins, Homolka, Wagner, and Zikmund. Nays: None. Absent: Kennedy.

The board discussed, but took no action, regarding the Census Report, Projected Enrollment, and the 25-26 Preliminary Budget.
