The Central City Board of Education met at 8:00 p.m., on Monday, January 19, 2026 in the Central City High School Conference Room at 1510 28<sup>th</sup> Street in Central City, NE 68826.

It was moved by Homolka, seconded by Kennedy, that it is hereby determined that this meeting was preceded by advanced notice by publishing in the Republican Nonpareil and by posting notices at the Superintendent's Office, Merrick County Courthouse and City Hall Office and is hereby declared to be duly convened in open session and a copy of the agenda is posted in the Superintendent's Office. The high school activities fund account disclosed a balance on December 31, 2025 of \$315,779.30, middle school activity fund disclosed a balance of \$18,072.15, and the elementary activity fund disclosed a balance of \$17,057.80. The cafeteria account disclosed a balance of \$-1,346.51.
