The board may elect to take action on any of the items listed but is not required to consider or take action on every item on the agenda.

The board may elect to go into executive/closed session when the board deems it legal and appropriate to do so.

The Central City Board follows the Nebraska Open Meetings Act. A copy of the Nebraska Open Meetings Act is posted on the bulletin board in the Conference Room.

C. Items:

1. Discuss & Take Any Necessary Action Regarding District/DayCare Partnership for the 2020-2021 School year D-1
2. Discuss & Take Any Necessary Action To Approve Additional Pre-School Program to be offered in July of 2020. All Services and expenses to be paid by Head Start.
3. Discuss & Take Any Necessary Action To Approve Summer School, Credit Recovery, ESY, and Driver's Education plans for June and July of 2020.
4. Board Work Session to Discuss 2020-2021 Goals & Strategic Planning
5. Review, consider, and take all necessary action to adopt a resolution (1) selecting the construction management at risk contract delivery system for the 2020 Construction Project, (2)designating members of the Construction Manager at Risk Selection Committee, (3) referring all construction manager at risk proposals to the Construction Manager at Risk Selection Committee, and (4) taking any other action deemed necessary regarding the selection of the construction management at risk contract delivery system or required by the Political Subdivisions Construction Alternatives Act. Nebraska Law 84-1408: Declaration of intent; meetings open to the public.

"It is hereby declared to be the policy of this state that the formation of public policy is public business and may not be conducted in secret.

"Every meeting of a public body shall be open to the public in order that citizens may exercise their democratic privilege of attending and speaking at meetings of public bodies, except as otherwise provided by the constitution of Nebraska, federal statutes, and the Open Meetings Act."

Nebraska Law 84-1411: Meetings of Public body: "The agenda shall not be enlarged later than twenty-four hours before the scheduled commencement of the meeting. The public body shall have the right to modify the agenda to include items of any emergency nature only at such public meeting."
